Through the entrance and main door is an area accommodating the hot drinks vending machines and then there is a purpose-built counter that houses the machines. Behind the counter, there are tables and racking which showcase all the individual vending machine stock.

The rear of the premises is shared with a carpenter so half of the back area is split with woodwork equipment and the other half is where the remaining vending machines are kept, that have been reconditioned or are ready to be shipped out.

All stock is included within the sale. However, a price would need to be negotiated for the equipment as there is a high number of machines included, all of which are in great condition.
