Surprisingly, for a longstanding business with an excellent reputation, the current owners have done very little marketing to promote the service. Most business derives from word of mouth and recommendations.

On average, they gain 6 new customers per month. Clients pay for services one year in advance and hardly ever lost their original clients. The business regularly changes 1000 bins for customers including: schools, factories, and offices. Predominantly working throughout Gloucestershire and Herefordshire, the business works as a fully licensed Waste Transfer Station, ensuring the correct disposal of waste with every job.

All bins are leased and are owned by the company, therefore an asset valued at approximately £10,000 - £15,000. Rental costs range from just £40 per month, which includes monthly service visits by their operatives. In terms of competition there are Cathedral and PHS, but these are large faceless companies with poor customer services records.
